God's Presence in the Sanctuary: A Theology of His Nearness This is an attempt to look at the sanctuary doctrine from what could be considered to be the center of the theology of the sanctuary, namely the nearness of God.

The heavenly sanctuary is cleansed by the blood of Jesus. This concept of the cleansing of the sanctuary comes from the Day of Atonement service which is spelled out in Leviticus chapter 16. Additional regulations are given in Leviticus 23, along with regulations for the other important holy days in the Israelite calendar.

These doctrines include the SDA belief that Sunday worship will result in the "Mark of the Beast," imbalanced teachings on keeping the commandments (baptism, Sabbath observance) that often implies a kind of salvation by works, the "Remnant Church" doctrine that implies that the SDA is or will be God's only true church, and the doctrine of the Investigative Judgment.
